#### **Facilitation Process Overview**

Resource Development Associates (RDA) shared a presentation that provided information regarding their background, role as facilitator and goal of the task force. Amalia Freedman, Dr. Charlene Taylor and Oliver Miller are a part of the facilitation team that will help facilitate the work of the task force. The facilitation team will be reaching out to each task force member to conduct interviews, to learn about the expectation for the process, and hear what areas the members would like to know more about, and what initiatives may intersect with this work. Results will be brought back to the group to help guide the work of the task force and the planning for subcommittees. This task force will help inform and create the seven CFJL plans. Each department/agency will have a specialized plan for their department based on feedback received.

#### Task Force Timeline

- 1. Launch Task Force: Review Data and Models March 2022
- 2. Map Ideal System: Develop County-Wide Plan September 2022
- 3. Develop Agency/ Department Plans March 2023

### **Approach to Planning Process**

On May 25, 2021, Alameda County Board of Supervisors (BOS) unanimously approved a "Care First, Jails Last" Policy Resolution. The Care First, Jails Last policy affirms that Alameda County values a comprehensive continuum of care for individuals with mental illness substance use and co-occurring disorders rather than incarceration. The policy also calls for a just and equitable transformation of criminal justice, behavioral health, and wraparound services that reduce the number of people with mental illness. This Brown Act Care First, Jails Last Task Force will be comprised of 25 members who are charged with developing a county-wide implementation plan subject to approval by the BOS, based on what was proposed by the Justice Involved Mental Health Task Force for the next two years. The 2-year process will be financed by each of the seven participating County Departments.

#### **Process and Outcomes**

- To create a County-wide plan.
- To Reduce incarceration of individuals with mental health and/or substance conditions.
- To Ensure transparent accountability and county-wide investment.
- To Promote the development of critical County departmental/agency implementation plans.
- To Improve the overall health & wellness of the broader Alameda County community.
