<p><b>7.1.A:</b> [162,54,10] Ensure that County-funded affordable housing projects follow Just Cause eviction and Fair Chance policies, allowing people who are formerly incarcerated/ criminalized and their families access to and stability in county-funded affordable housing units. <p><b>7.1.E:</b> [12,158] [Intercepts -2, -1, 4 &amp; 5] Allocate County funds towards permanent supportive housing programs and services for those who are unhoused or not adequately housed, suffering from mental illness and/or substance use disorders, and/or are formerly incarcerated.</p> <p>a. Invest \$80M, blend of reserves &amp; general fund, to expand supportive housing units. \$80 million would represent an increase from the approximately \$46 million from the County's General Fund allocated in FY 2021-2022, which accounted for about one quarter of all funds dedicated to the Home Together plan.</p> <p>b. Expand licensed Board-and-Care facilities, which have been reduced in Alameda County and are designed to support highly impacted persons experiencing mental illness and/or substance use disorders. <p><b>7.1.F:</b> For funding streams that the County receives for housing, the County housing agencies should be required to make a specific plan for how those funds will be used to create supportive housing units for people with serious mental illness, substance use disorders, co-occurring disorders, and/or criminal justice system involvement– including but not limited to supportive housing, crisis residential, licensed board &amp; cares, and permanent group housing with supportive on-site services. The plan should include a clear assessment of need and how this plan addresses that need, and an accounting of the number of dollars and number and type of supportive housing units that will be created for this special population. It should also incorporate information from cities in the County about supportive housing.
