#### **B.** Data Ad Hoc Committee Report from


Alameda County Behavioral Health Care (ACBH) has complied with the data sub-request and have provided a spreadsheet that involves demographic information for ACBH clients.

#### C. Recommendation Ad Hoc Committee Report

The committee has met twice and did an extensive review and feedback on the recommendations

- Section 4 Discussed crisis services recommendation and revised treatment bed recommendations provided by community members
- Section 5 Revised the diversion umbrella recommendations
- Section 11 Added a new section on family support
- Section 1 Discussed updates on the African American Center
- Section 7 Refined the housing recommendations

#### **Discussion & Action Items**

#### A. Recommendations Approval

Resource Development Associates (RDA) initiated the discussion by highlighting the fifty streamlined recommendations included in the meeting materials. The main objective is to collectively review any of the fifty recommendations that need further discussion and provide any feedback.

The next step involves finalization, after which the recommendations will be shared with each individual agency. Each agency will then provide an interim report on the progress of their plans. If any agencies deem changes necessary to the recommendations, it will be necessary to bring those adjustments and discussed during the CFJL Taskforce meeting next month for approval.

#### Sections 1.A and 1.B

- African American Resource Center (Center), also known as the African American Wellness Hub.
- Suggested to provide clarity regarding the target population.
- Suggested additions: (1) forensic FSP be housed; (2) and the Alameda County Probation be linked.
- Suggested alignment between navigation center and the Center

#### Section 2.A

- Suggested additional FSPs
- Suggested to incorporate fidelity (infrastructure and capacity)

#### Sections 2.5.A. and 2.6.C.

- Suggested addition to make referrals and assignments to FSPs or other service teams at intake to read as "... plan for referral to service providers for possible referral to collaborative court."
- Additional language to be included that encourages facilitation for a more therapeutic environment for the gravely disabled or "contained."
- Coordination/collaboration between Sta. Rita jail and facility

#### Section 2.4.C.

- Feasibility of cost and potential redundancy
- CalAIM database is being developed by Alameda County Information Technology Department (ITD) in collaboration between AC Healthcare and law enforcement
- Suggested an increase in collaboration between the agencies

#### Section 3

- Highlight public safety
- Suggested refinement of language to reference service rather than specific providers

#### Section 5.B.

- Probation staff providing pre-trail services program to individuals that allows them to be removed from custody and report to court
- Program includes mental health referrals and supervision
- Probation does not support the conditions of this recommendation, particularly
  concerning individuals who are not in custody but are reported and supervised
  by a law enforcement agency as it could potentially result in longer
  incarceration periods.
- Suggested to discuss further at next meeting

CFJL Taskforce Members to review the recommendations thoroughly and prepare to come to the next meeting with any feedback/questions. Additionally, each agency has been assigned an RDA liaison.
